### The People of the State of New York, represented in Senate and Assembly, do enact as follows:

- Section 1. The elder law is amended by adding a new section 225 to read as follows:
- § 225. Elder abuse enhanced multidisciplinary team program. 1. The is hereby authorized, subject to appropriation of funds for the program, to establish an elder abuse enhanced multidisciplinary team program consisting of teams at the regional or county level for complex cases of elder abuse, including but not limited to financial exploitation, physical abuse, psychological abuse, sexual abuse, and neglect, 9 involving a victim sixty years of age or older.
- 2. Such elder abuse enhanced multidisciplinary teams shall consist of 11 representation by professionals generally authorized to make decisions on behalf of their agency from public, private, and voluntary agencies. Represented professions may include, but are not limited to, 14 health/medical, mental health, aging, protective services, human services, social work, banking/financial institutions, legal services, 16 district attorney's offices, law enforcement agencies, and forensic accounting.

PURPOSE: This bill would authorize the New York State Office for the Aging to establish the Elder Abuse Enhanced Multidisciplinary Team Program, with teams consisting of representatives from a wide range of

professions for the purpose of responding to complex cases of elder abuse.

#### 2.

#### SUMMARY OF PROVISIONS:

Section 1 of the bill would create a new section 225 of the Elder Law authorizing the establishment of the Elder Abuse Enhanced Multidisciplinary Team Program. The program would consist of teams across the State established to provide a coordinated response to complex cases of elder abuse. Section 225 would provide for and identify the role of a coordinator for each such team. Lastly, Section 225 would allow for the sharing among team members of client-identifiable information regarding victims of elder abuse for purposes of facilitating team activities.

Section 2 of the bill would provide that the bill become effective immediately.

#### EXISTING LAW:

There is no existing law that relates to multidisciplinary teams established for the purpose of responding to cases of elder abuse.

#### LEGISLATIVE HISTORY:

No similar proposals have been previously submitted.

#### STATEMENT IN SUPPORT:

The Elder Abuse Interventions and Enhanced Multidisciplinary Team (E-MDT) Initiative has become a critical part of New York State's response to elder abuse. During the COVID-19 public health crisis, there has been a surge in instances of abuse and financial exploitation reported. The crisis has simultaneously created many obstacles in addressing these instances. E-MDTs have continued to meet virtually, ensuring continued interventions in elder abuse cases and protections for New York's older adults during a time when many other programs have been forced to pause. However, E-MDTs currently lack the statutory authorization, protections, and clarifications such as those afforded to child abuse MDTs under Section 423(6) of the Social Services Law. In particular, local organizations have noted potential legal issues around the sharing of victim information during case discussions, especially in light of the recent revisions to New York State's discovery laws. This has created uncertainties that make it difficult for local E-MDT Coordinators to recruit and onboard new team members representing county Adult Protective Services, District Attorney's offices, law enforcement, etc. Legislation would address these issues by establishing a statutory basis for the program and clarifying these issues, thereby allowing the  $\mathtt{E}\mathtt{-}\mathtt{MDT}$ Initiative to continue operating in the most effective and efficient manner.
